**Host Business Contract**

With participation in *Arts Evening*, the Host Business will comply with the rules and regulations set forth by the *Arts Evening* Committee, Department of Cultural & Public Affairs and City of Slidell, including, but not limited to the following:

**Prior to *Arts Evening* Night:**

1. The Host Business will be contacted by the Artist(s) no later than Friday, March 22, 2019, so that the artists may introduce themselves, discuss display space, special needs and decide on times to set up exhibits.
2. Host Businesses who represent their own artists must provide artist information to the Slidell Department of Cultural Affairs no later than Friday, March 8, 2019.
3. The Host Business will display an *Arts Evening* poster in its front window. This poster should arrive in March. The Committee asks that the poster be prominently displayed in your front door or window.
4. The Host Business will be given *Arts Evening* programs to keep in their business and hand out to customers. Additional programs can be provided upon request, and will be provided while quantities last.

***Arts Evening* Night:**

1. The Host Business will have its business and surrounding area cleaned and well lit for that night.
2. The Host Business will have display space clean and available for the Artist(s) and will give the Artist(s) ample time to set up the display.
3. The Host Business will be open for business from 4:00 to 9:00 p.m.
4. This year, we are once again requesting that businesses refrain from serving heavy refreshments (or limit refreshments to something very light, like cheese and crackers) so that *Arts Evening* patrons are encouraged to dine at participating restaurants.
5. The rain date for this event will be Sunday, April 7, 2019, from 4:00 to 9:00 p.m.  
***IMPORTANT:*** If you wish to participate in *Arts Evening* but are unable to remain open for the rain date, please indicate such on your Business Registration Form so that we may provide your artists with an alternative location for that night.
