CALL FOR ENTRIES

The City of Slidell is pleased to announce the 23rd annual Mixed Media competition sponsored by the City and its Commission on the Arts. The exhibit will be held at the Slidell Cultural Center at City Hall. Past exhibits displayed have included works by local, regional, national and international artists, as well as exhibitions from the New Orleans Museum of Art, the Smithsonian Institution Traveling Exhibition Service and other nationally recognized presenters.

JUROR - MATT RINARD, ARTIST AND OWNER OF GALLERY RINARD

Matt Rinard is an artist and the owner of Gallery Rinard in New Orleans. As a child, he was urged by his father not to go into art but "to get a real job." Nevertheless, Matt attended N.O.C.C.A. (New Orleans Center for Creative Arts) and later graduated from Florida State University with a degree in graphic design. Matt is the official artist for the Krewe of Barkus. He was commissioned by designer David Dart to create an exclusive clothing line for Saks Fifth Avenue, Neiman Marcus and Bloomingdale's. He has a greeting card line that is available in stores throughout North America. He was selected by the Gronou Jazz Festival in Germany to be their official artist. Matt works primarily in gouache, an opaque watercolor, and with printing, techniques, serigraphs and lithographs. ELIGIBILITY

All artists 18 years or older and residing in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee or Texas are eligible. Each artist is limited to three entries. Each work must be composed of two or more media. While computer and/or digital manipulation may be applied to artwork, the use of either of these technologies is not considered separate media. As such, digital artwork (such as digital photography) must be enhanced with a non-digital medium to constitute "mixed media." Work must be original and completed within the past two years and not previously exhibited in the Slidell Cultural Center.

AWARDS

A total of \$600 in awards will be presented: \$300 Award for Best of Show, \$200 Award for Second Place and \$100 Award for Third Place. Honorable Mentions may be awarded at the juror's discretion. Additionally, the City of Slidell will present a purchase award in conjunction with this event.

ENTRY

An entry fee of \$25 per artist must accompany the entry form. Make checks payable to City of Slidell. Entry in this exhibit is by high resolution color digital photographs only. Digital pictures will only be accepted in JPEG (.jpg) format and are not to exceed 5 x 7 and 300 dpi. Actual work submitted must be as depicted in the JPEG. Photos should not be altered in any way. No substitutions for accepted entries will be allowed; and no more than three entries per artist will be accepted. Submit one JPEG for each two-dimensional artwork and up to three JPEGs for each three-dimensional artwork. The filename of each JPEG must be labeled with the title of work and the artist's name. Be sure to print all information on entry form. Entry form must include value of each piece for insurance purposes. Work need not be for sale. All JPEGs must be submitted on a CD/DVD or a USB flash drive. The CD/DVD or USB drive, entry form and entry fee may be mailed to: City of Slidell, Attn: Alex Carollo, P.O. Box 828, Slidell, LA, 70459. Entries can also be hand delivered to 250 Bouscaren Street, Suite 304. Entries must be received no later than Thursday, Sept. 10, 2015. The Commission on the Arts reserves the right to choose not to display artwork.

SIZE & HANGING REQUIREMENTS

All paintings must be dry and wired. All hanging work must be wired to hang securely, and if framed, must meet professional standards. Each work must have the artist's name, telephone number and address displayed on the back of each piece. All hanging artwork must not exceed a total weight of 40 pounds. Additionally, the maximum size for all artwork is 40" wide by 60" high, including mat and frame. Freestanding work must not exceed 6' high or 36" wide. Due to the hanging system, installation pieces cannot be accepted.

LIABILITY

Utmost care will be exercised in the handling of entries. However, the City of Slidell will assume responsibility for damage or loss of accepted entries only for the period of time in which each piece of art is in the facility, between 1 p.m., Sept. 21, 2015, through 6 p.m., Nov. 3, 2015. The City of Slidell will not assume responsibility for works in transit or for works not picked up by 6 p.m. on Nov. 3, 2015.

DELIVERY & PICK-UP REQUIREMENTS

All accepted artwork must be delivered to the Slidell Cultural Center, 2055 Second Street, on Monday, Sept. 21, from 1 to 6 p.m. or Tuesday, Sept. 22, from 8 a.m. to 1 p.m. If you are shipping your artwork(s), please send to: City of Slidell, Attn: Alex Carollo, 250 Bouscaren St., Suite 304, Slidell, LA 70458. Due to space limitations, we are unable to accept shipped artwork which requires storage of packing materials. Artists may choose to ship their work, making sure that it arrives by Sept. 22, 2015, and only with the understanding that shipping materials will be discarded.

All art work must be picked up on Monday, Nov. 2, from 1 to 6 p.m. or Tuesday, Nov. 3, from 8 a.m. to 1 p.m. Artists are encouraged to pick up their work from the gallery but may also elect to send a prepaid shipping label with new packing materials. Artists are responsible for scheduling shipping pick-ups and for all shipping costs. The City of Slidell is not responsible for work damaged in transit. New shipping materials must arrive at the Slidell Cultural Center between Oct. 28 and Nov. 3, 2015. All entries must be available to display in the Slidell Cultural Center exhibit for the full duration of this show. If an entry is selected for the exhibit, but the artist chooses not to display the artwork, then the artist will be disqualified from exhibiting any works in the current and future Slidell Cultural Center exhibits. By entering artwork in this exhibit, the artists is agreeing to allow their work to be photographed for the purpose of promoting the City of Slidell's Mixed Media exhibits. No accepted artwork may be removed from the exhibit before the close of the show. Entry in this exhibit establishes an agreement on the part of the artist to all of these conditions.
