All art work must be picked up on Monday, Oct. 29, from 8 a.m. to 1 p.m. or Tuesday, Oct. 30, from 1 to 6 p.m. Artwork left 15 days past this deadline will become part of the City of Slidell's Public Art Collection.

CALL FOR ENTRIES

The City of Slidell is pleased to announce the 26th annual Mixed Media competition sponsored by the city and its Commission on the Arts. The exhibit will be held at the Slidell Cultural Center at City Hall. Past exhibits displayed have included works by local, regional, national and international artists, as well as exhibitions from the New Orleans Museum of Art, the Smithsonian Institution Traveling Exhibition Service, the Southern Arts Federation and other nationally recognized presenters.

JUROR

Carole Irby-Gray, an art teacher and artist, will serve as the juror for this year's exhibition. She recently relocated to Slidell after losing her home and 20 year body of artwork in the Denham Springs floods of 2016. She recently joined the Slidell Art League and accepted the co-publicity position. She is a past Board Member of Directors for Louisiana Arts and Artists Guild, where she held Vice President Office and the Publicity Chair for 2005 and 2006. She was the first art blogger for 225 Baton Rouge Magazine website, where she wrote about the arts in The Art Link column. She is also a freelance art teacher, having taught weekly classes in Baton Rouge for 14 years prior to the flood. She feels confident that she will be teaching in Slidell in the near future. Although she may have been uprooted and redirected by a flood, she certainly has insight and a vision of the art she is creating. Recently her artwork has evolved from her original realism style into graphic-realism, tweaked with an impressionistic slant. A European flavor is evident in her collages and many of her paintings based on her original photographs from her European travels, as well as her love of Louisiana flavor and architecture. She has also recently loosened her style while kicking up the color, adding bold primary colors and vibrant Caribbean colors to her works.

ELIGIBILITY

All artists 18 years or older and residing in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee or Texas are eligible. Each artist is limited to three entries. Each work must be composed of two or more media. While computer and/or digital manipulation may be applied to artwork, the use of either of these technologies is not considered separate media. As such, digital artwork (such as digital photography) must be enhanced with a non-digital medium to constitute "mixed media." Work must be original and completed within the past two years and not previously exhibited in the Slidell Cultural Center.

AWARDS

A total of \$600 in awards will be presented: \$300 Award for Best of Show, \$200 Award for Second Place and \$100 Award for Third Place. Honorable Mentions may be awarded at the juror's discretion.

ENTRY

An entry fee of \$25 per artist must accompany the entry form. Make checks payable to City of Slidell. Entry in this exhibit is by high resolution color digital photographs only. Digital pictures will only be accepted in JPEG format and are not to exceed 5 x 7 and 300 dpi. Actual work submitted must be as depicted in the JPEG. Photos of the artwork should not be altered in any way. No substitutions for accepted entries will be allowed; and no more than three entries per artist will be accepted. Submit one JPEG for each two-dimensional artwork and up to three JPEGs for each three-dimensional artwork. The filename of each JPEG must be labeled with the title of work and the artist's name. Be sure to type or neatly print all information on entry form. Entry form must include value of each piece for insurance purposes. Work need not be for sale. All JPEGs must be submitted on a USB, CD or DVD. The USB drive/CD/DVD, entry form and entry fee may be mailed to: Slidell Cultural Center at City Hall, P.O. Box 828, Slidell, LA, 70459. Entries can also be delivered to 250 Bouscaren Street, Suite 304. Entries must be received no later than Monday, Sept. 7, 2018. CD and DVDs will not be returned. Artist may pick up their USB flash drive from the Department of Cultural & Public Affairs by Oct. 30, 2018. Notification of artwork accepted or not accepted for the exhibit will be sent via email by Thursday, Sept. 13, 2018. No accepted artwork may be removed from the exhibit before the close of the show. The Commission on the Arts reserves the right to choose not to display artwork presented for exhibition at the Slidell Cultural Center.

SIZE & HANGING REQUIREMENTS

All work must be delivered dry and prepared to display. All hanging work must be wired to hang securely, and if framed, must meet professional standards. Each work must have the artist's name, telephone number and address displayed on the back of each piece. All hanging artwork must not exceed a total weight of 40 pounds. Additionally, the maximum size for all artwork is 40" wide by 60" high, including mat and frame. Freestanding work must not exceed 6' high or 36" wide. Due to the hanging system, installation pieces cannot be accepted.

LIABILITY

Utmost care will be exercised in the handling of entries. However, the City of Slidell will assume responsibility for damage or loss of accepted entries only for the period of time in which each piece of art is in the facility, between 8 a.m., Monday, Sept. 17, 2018, through 6 p.m., Tuesday, Oct. 30, 2018. The City of Slidell will not assume responsibility for works in transit or for works not picked up by 6 p.m. on Oct. 30, 2018.

DELIVERY & PICK-UP REQUIREMENTS

All accepted artwork must be delivered to the Slidell Cultural Center, 2055 Second Street, on Monday, Sept. 17, 2018, from 8 a.m. to 1 p.m. or Tuesday, Sept. 18, 2018, from 1 to 6 p.m. If you are shipping your artwork(s), please send to: Attn: Alex Carollo, Slidell Cultural Center at City Hall, 2055 Second Street, Slidell, LA 70458. Due to space limitations, we are unable to accept shipped artwork which requires storage of packing materials. Artists may choose to ship their work, making sure that it arrives at the Slidell Cultural Center by Tuesday, Sept. 18, 2018, and only with the understanding that shipping materials will be discarded.

All art work must be picked up on Monday, Oct. 29, 2018, from 8 a.m. to 1 p.m. or Tuesday, Oct. 30, 2018, from 1 to 6 p.m. Artists are encouraged to pick up their work from the gallery but may also elect to send a prepaid shipping label with new packing materials. Artists are responsible for scheduling shipping pick-ups and for all shipping costs. The City of Slidell is not responsible for work damaged in transit. New shipping materials must arrive at the Slidell Cultural Center between Oct. 22 and 26, 2018. The mailing address is: Slidell Cultural Center at City Hall, 2055 Second Street, Slidell, LA 70458.

All entries must be available to display in the Slidell Cultural Center exhibit for the full duration of this show. If an entry is selected for the exhibit, but the artist chooses not to display the artwork, then the artist will be disqualified from exhibiting any works in the current and future Slidell Cultural Center exhibits. By entering artwork in this exhibit, the artists is agreeing to allow their work to be photographed for the purpose of promoting the City of Slidell's Mixed Media exhibits. Entry in this exhibit establishes an agreement on the part of the artist to all of these conditions.
