8 **ORDINANCE NO. 2589**

10 An ordinance force annexing and zoning approximately 1.74 acres of land
11 lying West of Brookwood Subdivision and East of the W-14 Drainage Canal from Parish
12 to A-6 Single Family Urban zoning designation as petitioned by the City's Administration.

13
14 WHEREAS, the Slidell City Council has received a petition from
15 Administration to annex and zone approximately 1.74 acres of land from Parish to A-6
16 Single Family Urban zoning designation; and

17 WHEREAS, said land is bounded by Driftwood Circle and the W-14
18 Drainage Canal.

19 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
20 following described parcel of land be annexed into the corporate limits of the City of
21 Slidell into Councilmanic District G and zoned A-6 Single Family Urban, and is more fully
22 described as follows:

23 A certain tract or parcel of land, lying and being situated in Section 34, T8S-
24 R14E, Greensburg Land District, near the City of Slidell, St. Tammany
25 Parish, Louisiana, and being more fully described as follows:

27 From an iron rod reported to be located at the 1/4 Corner common to
28 Sections 34 & 35, T8S-R14E, said iron being the Northwest Corner of
29 Brookwood Estates Subdivision and the Point of Beginning of the tract
30 herein described, proceed S18-28-17W, 595.44 feet along the easterly R/W
31 line of a canal to a 1/2" iron rod set on the southerly R/W line of a 100 foot
32 Louisiana Power & Light Co. Right-of-Way; thence, proceed S38-30-00E,
33 303.75 feet along said southerly R/W line to a 1/2" iron rod; thence, return
34 along the westerly boundary of Brookwood Estates Subdivision, N00-01-
35 52W, 802.49 feet to the iron rod at the Point of Beginning.

37 Said tract contains 1.74 Acres of land. All in accordance with a plat of
38 survey by Clinton P. Lovell, P.L.S., Louisiana P.L.S. Registration No. 4520,
39 dated may 25, 1994, and bearing Job No. 101819.
