9 **ORDINANCE NO. 2669**

10 An ordinance amending Chapter 2 Administration, Article XI. Organizational  
11 Plan for City Government of the Code of Ordinances of the City of Slidell to provide for  
12 revisions in the Department of Cultural Affairs.

15 BE IT ORDAINED by the Slidell City Council that Chapter 2 Administration,  
16 Article XI, Organizational Plan for City Government of the Code of Ordinances of the City  
17 of Slidell is hereby amended as follows:  
18

19 Sec. 2-175, delete all language and replace with the following:

20 "Sec 2-175. Department of Cultural and Public Affairs

21 This department consists of two divisions:

22 (1) Division of Cultural Affairs

23 This division is responsible for fostering the arts, humanities, cultural events  
24 and certain civic events of the City of Slidell.

25 (2) Division of Public Affairs

26 This division is responsible for the dissemination of information regarding  
27 the City of Slidell, including the activities of the administrative and legislative  
28 branches, to the public. The duties of this division will be centered around  
29 the following functions:

30 (a) Provide timely and accurate information to the printed and electronic  
31 press regarding the activities of the City of Slidell.

32 (b) Design the Annual Report of the City of Slidell and oversee citizen  
33 distribution.

34 (c) Produce relevant programming on City Issues for cable television.

35 (d) Produce Public Service Announcements.

36 (e) Promote Slidell as the ideal place to "live, work and play."

37 (f) Design and print public information for citizen use.

6 (g) Coordinate the above efforts with interested private sector partners  
7 including the Chamber of Commerce, Convention and Tourism  
8 Bureau, Economic Development Foundation, etc.

9 The department shall also perform other related duties as may be assigned by the  
10 Mayor and the Chief of Staff."

11 BE IT FURTHER ORDAINED that said departmental name change is hereby  
12 reflected in the attached amended organizational chart dated March 26, 1996.




