8 **ORDINANCE NO. 2675**

11 An ordinance for the City of Slidell which shall set forth and designate the
12 adjusted millage rates as required by Paragraph B of Section 23, Article VII of the
13 Constitution of Louisiana, for the purpose of maintenance and operation of the Police
14 Department, Garbage Collection, Sewer System, Public Works, General Government, as
15 well as providing for the payment of interest and principal on outstanding general
16 obligation bonds, in said City for the year 1997.

17
18 **SECTION 1. BE IT ORDAINED** by the Slidell City Council of the City of
19 Slidell, Louisiana, in legal session convened, that there is hereby levied an aggregate tax
20 of thirty-eight and thirty-two one hundredths (38.32) mills on the dollar upon all property
21 taxable, under the laws of the State of Louisiana, situated in said City, according to the
22 assessment roll of said City in the calendar year 1997.

23 **SECTION 2. BE IT FURTHER ORDAINED** that said aggregate tax is
24 composed of the following individual authorized tax levys: a tax of 6.11 mills for the
25 purpose of raising and providing sufficient revenues to pay and defray the expenses of
26 the municipal government and for the general municipal and local purposes in the City
27 of Slidell, Louisiana, for the year 1997, as shown by the budget for the year 1997,
28 adopted by the City Council of said City. So authorized by Louisiana Constitution Article
29 VI, Section 27 at 6.11 mills.

30 A tax of 3 mills for the purpose of maintenance and operation of the Municipal
31 Police Department in the City of Slidell, Louisiana, for the year 1997. So authorized by
32 the special taxpayer election held in the City of Slidell, Louisiana, November 8, 1984.

33 A tax of 2.50 mills for the purpose of maintenance and operation of the Municipal
34 Police Department in the City of Slidell, Louisiana, for the year 1997. So authorized by
35 the special taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.

36 A tax of 5 mills for the purpose of garbage disposal and maintenance in the City
37 of Slidell, Louisiana, for the year 1997. So authorized by the special taxpayer election
38 held in the City of Slidell, Louisiana, September 27, 1986.

6 A tax of 5 mills for the purpose of maintenance of the sewerage system of the City
7 of Slidell, Louisiana, for the year 1997. So authorized by the special taxpayer election
8 held in the City of Slidell, Louisiana, September 27, 1986.

9 A tax of 2.5 mills for the purpose of maintaining, operating, and improving public
10 works within the City of Slidell, Louisiana, for the year 1997. So authorized by the special
11 taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.

12 A tax of 1.42 mills for the purpose of providing an amount sufficient to pay interest
13 and maturing bonds for the 1977 Drainage Improvement Bonds Series B of the City of
14 Slidell, Louisiana for the year 1997, as duly authorized by a special taxpayers election
15 held April 13, 1976, and by a Resolution of the Mayor and the Councilmen of the City of
16 Slidell, Louisiana, passed on the 13th day of April 1976, and the 16th day of November,
17 1976.

18 A tax of 2.18 mills for the purpose of providing an amount sufficient to pay interest
19 and maturing bonds for the 1977 Sewerage Improvement Bonds of the City of Slidell,
20 Louisiana, for the year 1997, as duly authorized by a special taxpayers election held April
21 13, 1976, and by a Resolution of the Mayor and the Councilmen of the City of Slidell,
22 Louisiana, passed on the 13th day of April 1976, and the 16th day of November, 1976.

23 A tax of 2.71 mills for the purpose of providing an amount sufficient to pay interest
24 and maturing bonds for the 1989 Water Bonds Series A, and 1989 Sewer Bonds Series
25 B, and the 1989 Refunding Bonds Series C of the City of Slidell, Louisiana, for the year
26 1997, as authorized by a special taxpayers election held November 8, 1988, and by a
27 Resolution of the Mayor and the Councilmen of the City of Slidell, Louisiana, passed on
28 the 24th day of January 1989.


29 A tax of 2.83 mills for the purpose of providing an amount sufficient to pay
30 interest and maturing bonds for the 1994 General Obligation Refunding Bonds of the City
31 of Slidell, Louisiana, for the year 1997, as authorized by a special election held November
32 8, 1988, and by a Resolution of the Mayor and the Council Members of the City of Slidell,
33 Louisiana, passed on the 8th day of March, 1994.


