ORDINANCE NO. 2926

An ordinance annexing and zoning a parcel of land containing .2178 acres located in Section 4, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, from Parish C-2 Highway Commercial to City A-4 Transitional zoning as petitioned by Vic Planetta, Landmark Investments & Construction, LTD.

WHEREAS, the Slidell City Council has received a petition from Vic Planetta, Landmark Investments & Construction, LTD, to annex and zone a parcel of land containing .2178 acres of land from Parish C-2 Highway Commercial to City A-4 Transitional zoning; and

WHEREAS, said property is located south of Highway 190 West and Maris Stella Avenue (driveway off Maris Stella).

NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the following described parcel of land be annexed into the corporate limits of the City of Slidell into Councilmanic District D and zoned City A-4 Transitional, and more fully described as follows:

A certain parcel of land located in Section 4, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, more particularly described as follows, to-wit;

Commence at the Northeast Corner of Section 38, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, thence, South 27 degrees 15 minutes West, 235.0 feet, thence, South 13 degrees 00 minutes East, 775.5 feet, thence North 73 degrees 00 minutes East, 1389.0 feet, thence, North 13 degrees 36 minutes West, 30.0 feet, thence, South 74 degrees 02 minutes 57 seconds West, 154.3 feet, thence North 03 degrees 22 minutes 58 seconds West, 279.83 feet, to the Point of Beginning, thence, North 03 degrees 22 minutes 58 seconds East, 316.40 feet, thence, South 03 degrees 22 minutes 58 seconds East, 30.0 feet, thence, south 88 degrees 07 minutes 00 seconds West, 316.40 feet, to the Point of Beginning, containing 0.2178 Acre.

BE IT FURTHER ORDAINED that the conditions of this annexation and zoning shall be as follows:

 The entire property be resubdivided, including the annexed portion, in accordance with the procedures of the subdivision regulations of the City of Slidell.

- 2. That the lots facing Maris Stella and Rummel Streets (less and except the driveway portion of the property) be developed into single family homes with lots no less than the 7500 square feet as required under the A-4 Zoning District, and that only one living unit shall be placed on these lots.
- 3. That the restrictions on the property be the same as placed on homes in Carolyn Park Subdivision, and further that no housing unit shall contain less than 1350 square feet of living area. All set-backs contained in the A-4 Zoning District shall apply.
- 4. That the remainder of the property be developed into multi-family in accordance with the requirement of the Slidell Zoning Code and in particular the A-4 Transitional Zoning District.
