5 **ORDINANCE NO. 4123**

6 An ordinance amending the Code of Ordinances of the City of Slidell, Chapter  
7 2, Article III, Division 4, Section 2-157 (Mayor Compensation).  
8

10 WHEREAS, the City of Slidell's Home Rule Charter, Article III, Section 3-06,  
11 provides that the Mayor's salary shall be established annually by ordinance through the  
12 budget process and that no ordinance changing the Mayor's salary shall increase such  
13 salary by more than the average percentage of increase granted annually to all city  
14 employees; and

18 WHEREAS, the average percentage of increase in salary granted to all City  
19 employees, as proposed in the City's budget for the 2023-2024 fiscal year, is at least three  
20 and one half (3.5%) percent (inclusive of a proposed uniform two (2%) percent cost of  
21 living adjustment for all employees); and

25 WHEREAS, subject to the adoption of the 2023-2024 fiscal year budget  
26 reflecting an average percentage of increase in salary granted to all City employees of at  
27 least three and one half (3.5%) percent (inclusive of a proposed uniform two (2%) percent  
28 cost of living adjustment for all employees), the Mayor will receive a three and one half  
29 (3.5%) percent salary increase.

33 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that, upon  
34 adoption of the City's budget for the 2023-2024 fiscal year, and effective July 1, 2023, the  
35 salary of the Mayor shall be set at \$135,893.00 and that the Code of Ordinances of the


