2. **Minutes.** Motion by Vice Chair Granier to approve minutes of September 25, 2024 as written; Chair Clayton seconded. A vote of 2 YAYS, 0 NAYS, 0 ABSTAIN approved the minutes.

3. **Public Hearings**

a. **CA24-42:** A request for a Certificate of Appropriateness for exterior alterations at 334 Teddy Avenue.

Introduced by Chair Clayton. Angela Williams, homeowner, was present to answer questions by the Commission. Director McElmurray addressed the Commission and recommended approval. Vice Chair Granier made a motion to approve, seconded by Chair Clayton. A vote of 2 YAYS, 0 NAYS, 0 ABSTAIN approved **CA24-42**.

b. **CA24-44:** A request for a Certificate of Appropriateness for new construction at 1715 Sgt Alfred Drive.

Introduced by Chair Clayton. Chris and Dylan Zimmer, owners/contractors, were present to answer questions by the Commission. Director McElmurray addressed the Commission and recommended approval. Chair Clayton made a motion to approve with the additional approval of a 6-foot wooden fence with application of a Fence Permit. Vice Chair Granier seconded. A vote of 2 YAYS, 0 NAYS, 0 ABSTAIN approved **CA24-44**.

a. Director McElmurray spoke to the Commission about 155 Robert Street and informed them of a new proposed project for a barber shop.
