EMERGENCY ORDINANCE NUMBER 1282

WHEREAS, the City of Slidell, on June 18, 1962, by Ordinance Number 659, annexed certain property known as Pollard Estates Subdivision (which subdivision was later re-named Slidell Country Club Estates);

WHEREAS, in June of 1972, the City of Slidell accepted and approved the survey plat of Slidell Country Club Estates, Fourth Filing, and authorized the filing of the plat of survey with the Clerk of Court in Covington, Louisiana;

WHEREAS, it was the intent of the owner, Pollard Estates Developing Corporation, and the City of Slidell that all of the Fourth Filing be included within the annexed area;

WHEREAS, it was later discovered that a small portion of property in the Fourth Filing was omitted from the description of the property annexed by the City of Slidell;

WHEREAS, all persons living in Slidell Country Club Estates, Fourth Filing, have been receiving city services and paying city taxes for years;

WHEREAS, it is necessary to pass this emergency ordinance so that the city is not required to immediately withdraw the city services in this area, and in particular, the right to water and sewerage collection and treatment services.

NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council, in legal session convened, that all of Slidell Country Club Estates, Fourth Filing, be and it is hereby annexed into the City of Slidell, and in particular, the following described property, all in accordance with the plat of survey previously referred to above and on record with the office of the Clerk of Court, Covington, Louisiana:
