ORDINANCE NO. 1305

6 An Ordinance to provide for participation by the City of  
7 Slidell in the Louisiana Municipal Risk Management Agency  
8 initially to share the risk and administration of workmen's  
9 compensation and employer liability claims and subsequently  
10 at the option of the applicant and Agency if a subsequent  
11 fund is established, to share the risk of public liability  
12 claims; to authorize the Mayor to contract to join in such  
13 Agency; and to authorize the Mayor to expend funds of the  
14 City of Slidell to contribute to the group self insurance  
15 fund of such Agency as to workmen's compensation and  
16 employer liability claims.

17  
18 WHEREAS, the City of Slidell is required to make payment for workmen's  
19 compensation and employer liability claims of its employees injured in the line  
20 and scope of their duties, and

24 WHEREAS, Act No. 462 of the 1979 Louisiana Legislature authorized two (2) or  
25 more municipalities to create an interlocal risk management agency which might then  
26 establish a group self insurance fund for workmen's compensation and employer  
27 liability claims; and

32 WHEREAS, the Louisiana Municipal Risk Management Agency has been created  
33 by an Agreement between two or more municipalities adopted pursuant to Act. No. 462  
34 of the 1979 Louisiana Legislature, and

38 WHEREAS, it is desirable for the City of Slidell to join the Louisiana  
39 Municipal Risk Management Agency and participate in its group self insurance fund  
40 in order to more efficiently provide a method of risk sharing for workmen's  
41 compensation and employer liability claims of its employees;

46 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in legal session  
47 convened, that the City of Slidell join the Louisiana Risk Management Agency and  
48 participate in its group self insurance fund which has been formed to service the  
49 workmen's compensation and employer liability claims of the employees of the  
50 municipalities joining the Agency;

56 BE IT FURTHER ORDAINED that the Mayor be authorized to execute and the  
57 Clerk attest the application to join the Louisiana Municipal Risk Management Agency  
58 and participate in its group self insurance fund with respect to workmen's  
59 compensation and employer liability claims in the form and substance of the  
60 Application attached hereto as Exhibit A;

3 BE IT FINALLY ORDAINED that the City of Slidell expend the annual  
4 premium necessary as its contribution to the group self insurance fund for  
5 workmen's compensation and employer liability risk sharing maintained or to be  
6 established by the Louisiana Municipal Risk Management Agency.
