ORDINANCE NUMBER 1321

ACQUISITION OF PROPERTY

BE IT ORDAINED by the City Council of the City of Slidell,
in legal session convened, that the City of Slidell accept the dona-
tion of the below described property and that the Honorable M. W.
"Webb" Hart, Mayor, be and he is hereby authorized to sign any and
all necessary documents in order to carry out the proper and complete
acquisition of the property, which is described as:

ALL THAT CERTAIN LOT OR PARCEL OF LAND, together with all
buildings and improvements thereon, situated in Section 2,
Township 9 South, Range 14 East, in BON VILLAGE SUBDIVISION,
City of Slidell, St. Tammany Parish, Louisiana, and being
more fully described as follows, to-wit:

From the northeast corner of the southeast quarter of the
southeast quarter of Section 2, Township 9 South, Range 14
East, go south 462.74 feet to a point; thence go North 89
degrees 51 minutes 37 seconds West 180.0 feet to the point
of beginning.

Thence from the point of beginning go North 00 degrees 06
minutes 10 seconds East 135.0 feet to a point; thence go
due West 39.0 feet to a point; thence go North 00 degrees
06 minutes 10 seconds East 130.0 feet to a point; thence
go North 89 degrees 51 minutes 37 seconds West 285.0 feet
to a point; thence go South 00 degrees 06 minutes 10 seconds
East 265.0 feet to a point; thence go North 89 degrees 51
minutes 37 seconds East 324.0 feet back to the point of be-
ginning.
