ORDINANCE NO. 1326

An Ordinance amending the Slidell Zoning Ordinance No. 795.

BE IT ORDAINED by the Slidell City Council, in legal session convened,
that the Slidell Zoning Ordinance No. 795 for the City of Slidell is hereby
amended as follows:

Section 2.4, A-1 Suburban District, Subsection 2.402: After the
word "herein", add the words and trailers, except as used for temporary offices
for construction purposes.

Section 2.5, A-2 Single Family Residential, Subsection 2.502: After
the word "herein", add the words and trailers, except as used for temporary
offices for construction purposes.

Section 2.6, A-3 Multi-family Residential, Subsection 2.602: After
the word "herein", add the words and trailers, except as used for temporary
offices for construction purposes.

Section 2.7, A-4 Transitional, Subsection 2.702: After the word
"herein", add the words and trailers, except as used for temporary offices for
construction purposes.

Section 2.9, A-6 Single Family Urban, Subsection 2.902: After the
word "herein", add the words and trailers, except as used for temporary offices
for construction purposes.

Section 2.10, A-7 Multi-family Urban, Subsection 2.1002: After the
word "herein", add the words and trailers, except as used for temporary offices
for construction purposes.

Section 2.11, A-8 High Density Urban, Subsection 2.1102: After the
word "herein", add the words and trailers, except as used for temporary offices
for construction purposes.

Section 2.12, A-9 Apartment District, Subsection 2.1202: After the
word "herein", add the words and trailers, except as used for temporary offices
for construction purposes.

Section 2.13, A-9-C Apartment Commercial District, Subsection 2.1302:
After the word "herein", add the words and trailers, except as used for temporary
offices for construction purposes.

Section 2.16, C-2 Neighborhood Commercial, Subsection 2.1602: After the word "herein", add the words and trailers, except as used for temporary offices for construction purposes.

Section 2.17, C-3 Central Business District, Subsection 2.1702: After the word "uses:", add the words Trailers, except for the sale of trailers, and as used for temporary offices for construction purposes, and other

Section 2-18, C-4 Highway Commercial, Subsection 2.1802: After the word "uses:", add the words Trailers, except for the sale of trailers, and as used for temporary offices for construction purposes, and other
