ORDINANCE NO. 1329

An Ordinance amending Ordinance No. 1259, an ordinance appropriating funds to implement the Operating Budget and the Capital Improvement Program for the Fiscal Year of 1980-81.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that Ordinance No. 1259, an ordinance appropriating funds to implement the Operating Budget and the Capital Improvement Program for the Fiscal Year of 1980-81, is amended as follows:

General Fund

Page 1, Line 28: Deduct \$96,800 leaving a balance of \$246,033.

Page 1, Line 30: Add \$600 leaving a balance of \$87,690

Page 1, Line 32: Add \$3,000 leaving a balance of \$45,534

Page 1, Line 34: Add \$60,000 leaving a balance \$1,110,228

Page 1, Line 38: Add \$3,800 leaving a balance of \$55,404

Page 1, Line 40: Add \$1,000 leaving a balance of \$72,036

Page 1, Line 42: Deduct \$106,800 leaving a balance of \$93,312

Page 1, Line 44: Add \$4,700 leaving a balance of \$102,716

Page 1, Line 48: Add \$600 leaving a balance of \$69,040

Page 1, Line 56: Add \$1,000 leaving a balance of \$136,993

Sales Tax

Page 1, Line 62: Deduct \$95,600 leaving a balance of \$575,362

Page 1, Line 64: Add \$11,400 leaving a balance of \$275,702

Page 2, Line 2: Add \$60,000 leaving a balance of \$436,274

Page 2, Line 4: Add \$7,000 leaving a balance of \$219,278

Page 2, Line 6: Add \$7,500 leaving a balance of \$129,739

Page 2, Line 10: Add \$1,600 leaving a balance of \$71,118

Page 2, Line 12: Add \$5,600 leaving a balance of \$83,923

Page 2, Line 14: Add \$2,500 leaving a balance of \$60,591

Utility Fund

Page 2, Line 20: Deduct \$33,300 leaving a balance of \$282,940

Page 2, Line 22: Add \$5,300 leaving a balance of \$206,172

Page 2, Line 24: Add \$28,000 leaving a balance of \$449,686




