ORDINANCE NO. 1330

An Ordinance of the City of Slidell, Louisiana, zoning a  
parcel of land.

WHEREAS, the City Council of the City of Slidell, Louisiana, the  
governing body of said municipality, did receive a petition from Margaret C. Rennie  
representing the Aldersgate Methodist Church, requesting the zoning to A-6  
Single Family Urban the following described property, and

WHEREAS, the Slidell Planning Commission, in a letter dated November 19th,  
1980, recommends approval of such zoning, and

WHEREAS, by publication in the Slidell Daily Times on December 5th, 12th,  
and 19th, 1980, the Council gave notice of their intention to take action on said  
petition by calling a public hearing on December 23rd, 1980, at 4:00 P.M., in  
the Council Chambers.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Slidell,  
Louisiana, in legal session convened, that the following described property be  
zoned A-6 Single Family Urban (Council District G):

A certain parcel of land situated in Section 36, Township 8  
South, Range 14 East, St. Tammany Parish, Louisiana, being  
more fully described as follows:

From the Southwest corner of said Section 36, go East 469.1  
feet to an iron and the point of beginning; thence North  
496.97 feet to an iron; thence North 23 degrees, 57 minutes,  
10 seconds West 154.75 feet to an iron set in the Southerly  
edge of Robert Road; thence Northeasterly along said South-  
erly edge in three courses:

North 37 degrees, 23 minutes, 50 seconds East 50.0 feet to an iron;  
North 38 degrees, 45 minutes, 30 seconds East 100.0 feet to an iron; and  
North 37 degrees, 08 minutes, 30 seconds East 146.2 feet to an iron;

thence South 8 degrees, 05 minutes, 55 seconds East 881.45 feet to  
an iron; thence West 242.7 feet to the point of beginning.

Containing in all 3.56 acres of land, more or less.
