## ORDINANCE NO. 1362

An ordinance amending Ordinance No. 1160, an ordinance defining, regulating and licensing peddlers and providing penalties for the violation thereof, adopted April 10th, 1979.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that Ordinance Number 1160, an ordinance defining, regulating, and licensing peddlers and providing penalties for the violation thereof, is amended to read as follows:

Page 1, Section 1. License Required: Add the following paragraphs:

In the case of itinerant markets or mobile vendors dealing in produce, seafood or any other form of food stuff, the applicant must first secure a permit to operate as a retail food establishment from the local office of the Louisiana Health and Human Resources Administration. Said permit shall be verified by the City of Slidell Finance Department. Furthermore, itinerant markets or mobile vendors dealing in perishable foods shall provide an enclosed vehicle equipped with proper refrigeration. All wastes, liquid or solid, from itinerant market must be disposed of in the city sewer system. Approved toilet and hand washing facilities shall be provided on the premises. Prior to the issuance of any city permit, itinerant markets or mobile vendors dealing in produce, seafood or any other form of food stuff shall produce for inspection by the City of Slidell a duly authorized and inspected legal scale. Said scale shall be used for the purpose of weighing all such produce, seafood or any other form of food stuff sold within the City of Slidell.

In the case of itinerant markets or mobile vendors dealing in any form of seafood, the applicant must be in possession of a current commercial fisherman's license. The number of permits issued under this section shall be limited to one (1) per Louisiana Commercial Fisherman's License, but in no event shall any person receive more than one (1) permit. A Louisiana Commercial Fisherman's License is required in order to obtain a permit from the City of Slidell.

Line 45, a-1: Delete \$25.00" and replace with  $\underline{\$50.00}$ ; Delete "\$50.00" and replace with  $\underline{\$100.00}$ ; delete "\$100.00" and replace with  $\underline{\$200.00}$

Page 3, Section 5, Paragraph c: Delete lines 23 through 25.

Page 3, Section 6. License Plates and Badges:

Line 31: Delete the words "two license plates for each"

Line 33: Delete the words "vehicle to be used, plus...metal"

Line 35: Delete the words "license plates or"

Lines 39 through 43: Delete the sentence "License plates shall be attached to the vehicle used by the licensee, either on both sides or on the front and rear of the vehicle so used."

Page 4, Section 9. Use of Streets.

Line 33: After the word "force", add: However, in no event shall the permittee or anyone else be allowed to peddle their wares within one thousand (1,000) yards of an established retail outlet that sells similar wares. Under no condition may a permittee locate on any public property or public right-of-way.

Page 5, Section 15. Penalty:

Line 49: Delete the words and number "one-hundred (\$100.00)" and replace with the words and number five-hundred (\$500.00)

Page 6, Line 25: Add the following:

Section 20. Regulations for Mardi Gras and Other Officially Recognized Parade Days.

Peddlers doing business only on these specific days shall obtain a license valid only for the day of the given parade. Fee for said license shall be \$25.00 for each person.
