An ordinance amending Budget Appropriations Ordinance  
Number 1259 to transfer all Revenue Sharing pay plan  
implementation monies to the correct department in the  
General and Sales Tax Funds, and to restate the allocation  
of Revenue Sharing Funds in a simplified form.




