8 An ordinance for the City of Slidell which shall set forth and designate the  
9 adjusted millage rates as required by Paragraph B of Section 23, Article VII of the  
10 Constitution of Louisiana, for the purpose of maintenance and operation of the Police  
11 Department, Garbage Collection, Sewer System, Public Works, General Government,  
12 as well as providing for the payment of interest and principal on outstanding general  
13 obligation bonds, in said City for the fiscal year 2003.

14 SECTION 1. BE IT ORDAINED by the Slidell City Council of the City of  
15 Slidell, Louisiana, in legal session convened, that there is hereby levied an aggregate  
16 tax of thirty-four and fifty-eight one hundredths (34.58) mills on the dollar upon all  
17 property taxable, under the laws of the State of Louisiana, situated in said City,  
18 according to the assessment roll of said City in the calendar year 2002.  
19

20 SECTION 2. BE IT FURTHER ORDAINED that said aggregate tax is  
21 composed of the following individual authorized tax levys:  
22

23 A tax of 6.18 mills for the purpose of raising and providing sufficient revenues to  
24 pay and defray the expenses of the municipal government and for the general municipal  
25 and local purposes in the City of Slidell, Louisiana, for the year 2003, as shown by the  
26 budget for the year 2003, adopted by the City Council of said City. So authorized by  
27 Louisiana Constitution Article VI, Section 27 at 6.18 mills.  
28

29 A tax of 3.0 mills for the purpose of maintenance and operation of the Municipal  
30 Police Department in the City of Slidell, Louisiana, for the year 2003. So authorized by  
31 the special taxpayer election held in the City of Slidell, Louisiana, November 8, 1984.

5 A tax of 2.53 mills for the purpose of maintenance and operation of the Municipal  
6 Police Department in the City of Slidell, Louisiana, for the year 2003. So authorized by  
7 the special taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.

10 A tax of 5.0 mills for the purpose of garbage disposal and maintenance in the  
11 City of Slidell, Louisiana, for the year 2003. So authorized by the special taxpayer  
12 election held in the City of Slidell, Louisiana, November 8, 1994.  
13

15 A tax of 5.0 mills for the purpose of maintenance of the sewerage system of the  
16 City of Slidell, Louisiana, for the year 2003. So authorized by the special taxpayer  
17 election held in the City of Slidell, Louisiana, November 8, 1994.  
18

20 A tax of 2.46 mills for the purpose of maintaining, operating, and improving public  
21 works within the City of Slidell, Louisiana, for the year 2003. So authorized by the  
22 special taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.


25 A tax of 4.54 mills for the purpose of providing an amount sufficient to pay  
26 interest and maturing bonds for the 1994 General Obligation Refunding Bonds of the  
27 City of Slidell, Louisiana, for the year 2003, as authorized by a special election held  
28 November 8, 1988, and by a Resolution of the Mayor and the Council Members of the  
29 City of Slidell, Louisiana, passed on the 8th day of March, 1994.

32 A tax of 5.87 mills for the purpose of providing an amount sufficient to pay  
33 interest and maturing bonds for the 1996 General Obligation Bonds for the City of  
34 Slidell, Louisiana, for the year 2003, as authorized by a special election held November  
35


