# Sec. 10-33. Fee Schedule for Heritage Park Structures.

**A.** The fee schedule for structures located in Heritage Park which are available for rent shall be as follows:

  - Group 2: Non-profit corporations as defined by R.S. 12:201, et seq., and having three-fourths of its membership residing in St. Tammany Parish, schools located within St. Tammany Parish or such school sponsored organizations, and private individuals residing in St. Tammany Parish.

- Group 3: Non-profit corporations as defined by R.S. 12:201, et seq., having less than three-fourths of its membership residing in St. Tammany Parish, schools located outside St. Tammany Parish and such school sponsored organizations, and private individuals residing outside St. Tammany Parish.
- 4. Group 4: Profit making corporations or companies.
- 5. Public agencies are agencies of a federal, state, parish or municipal government, or a state political subdivision.
- Public agencies using facilities for activities not open to the general public or for profit making activities shall be subject to Group 2 fee charges.
- C. The provisions of Sec. 10-26 relating to the use of alcohol shall be applicable to persons renting the Gazebo or Scoggin Station.
