8 An ordinance authorizing the Mayor of the City of Slidell to execute an Act of
9 Sale for certain immovable property located on Lot 25, Section I, Bayou Bonfouca Estates
10 Subdivision, Municipal Address: 121 Bywater Drive, Slidell, Louisiana, in connection with
11 the Federal Emergency Management Agency (FEMA) flood mitigation program.

12 WHEREAS, the City of Slidell has received funding to purchase or elevate
13 floodprone structures in the City as a continuation of the FEMA flood mitigation program;

18 Bonfouca Estates Subdivision, Municipal Address: 121 Bywater Drive, due to the extreme
19 flood losses incurred over the life of the structure, is eligible for purchase under this FEMA

24 property located on Lot 25, Section I, Bayou Bonfouca Estates Subdivision, Municipal
