## **ORDINANCE NO. 3212**

An ordinance rezoning 27.532 acres of land situated west of I-10 and east of Tanglewood Subdivision, from C-4 Highway Commercial and A-9-C Apartment Commercial District to A-6 Single Family Residential, as petitioned by O. Miles Pollard, Jr.
