7 An ordinance revoking the Strawberry Street right-of-way located between
8 U.S. 190 and Lot 11, Sq. 7, Northside Subdivision, as petitioned by Elwin C. Ordoyne, III
9 and Michael L. Perkins, Sr.

11 WHEREAS, the Slidell City Council has received a request from Elwin C.
12 Ordoyne, III and Michael L. Perkins, Sr. to revoke the Strawberry Street right-of-way; and

14 WHEREAS, the Slidell Planning Commission has issued an unfavorable
15 recommendation to revoke the Strawberry Street right-of-way because of a 6-inch water
16 line in this right-of-way.

19 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
20 hereby revoke the Strawberry Street right-of-way located between U.S. 190 and Lot 11 Sq.
21 7, Northside Subdivision, and more fully described as follows:

24 This property is more particularly described as: A certain parcel of land being
25 Strawberry Street, lying and situated between U.S. 190 and Lot 11, Sq. 7,
26 Northside Subdivision, City of Slidell, St. Tammany Parish, Louisiana and more
27 full described as follows: From a fnd. 1/2" iron rod, the Point of Beginning as
28 shown on above referenced survey # 1050061 which is also the northeast
29 property corner of Lot 11 at Audubon Street; thence go Westerly 120.00 feet to
30 a fnd. 1/2" iron rod, the northwest corner of said Lot 11; thence Northerly 45.00
31 feet to the northern r/w line of Strawberry Street; thence Easterly 39.35 feet
32 along said r/w line to intersection with the southern r/3 line of U.S. # 190;
33 thence Southeasterly 86.71 feet along the southern r/w line to intersection with
34 the west r/w line of Audubon Street; thence Southerly 14.95 feet along said
35 west r/w line to the Point of Beginning. Said r/w portion containing 4,188.2 sq.
36 ft., lying and situated between U.S. #11 and Lot 11, Sq. 7, Northside S/D, City
37 of Slidell, Saint Tammany Parish, Louisiana.


