ORDINANCE NO. 3345

An ordinance amending the Code of Ordinances of the City of Slidell, Chapter
10 Civic and Cultural Affairs and Facilities, by amending the fee and use structure for the
City Auditorium, Recreation Center and the Rufus Viner Center.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
hereby amend the Code of Ordinances of the City of Slidell, Chapter 10 Civic and Cultural
Affairs and Facilities, as follows:

Sec. 10-23. Written agreement required for use.

Add a new sentence at the end of the paragraph, "Any misrepresentation on
this contract will result in a civil penalty of \$500.00 and no use of any City building for five
(5) years."

Sec. 10-27. Types of groups.

Delete paragraph (2) under "a" and replace with the following:

"(2) Group 2: Nonprofit corporations, as defined by R.S. 12:201 et seq., (having
three-fourths of its membership residing inside St. Tammany Parish, and a copy of
Corporate Charter stating your nonprofit status), schools, or school-sponsored
organizations."

- (1) Discounts shall be given at the rate of ten percent for multiple-day bookings and 50 percent for nonprofit senior citizens' organizations. A senior citizens' organization is defined as an organization where a minimum of 75 percent of the active members exceed 60 years of age.

- 4 (2) Except for functions sponsored by Mardi Gras Krewes or nonprofit
 5 organizations, there shall be no rental of city buildings on the following city
 6 holidays: New Year's Eve, New Year's Day, Martin Luther King Day, Mardi
 7 Gras Day, Good Friday, Memorial Day, Fourth of July, Labor Day,
 8 Thanksgiving Day, Day after Thanksgiving, Christmas Eve, Christmas Day,
 9 and the Day after Christmas. If exceptions to this rule are made by the Mayor,
 10 fees on these days shall be at the rate of 1 1/2 times the regular rate.
- 11 (3) Full payment of all fees shall be made not less than 14 calendar days prior to
 12 the event. Failure to pay all fees and deposit as required shall result in
 13 automatic cancellation of the booking date.






