8 An ordinance authorizing the Mayor to sign a lease agreement with Urgent  
9 Care Services, LLC. to operate as a non-commercial aviation operator at the Slidell  
10 Airport.

11 WHEREAS, the City of Slidell, hereinafter referred to as "City," now operates  
12 a public airport designated as the Slidell Airport located in Slidell, St. Tammany Parish,  
13 Louisiana, hereinafter referred to as "Airport;" and

14 WHEREAS, the City deems it advantageous to itself and to its operation of  
15 the Airport to lease unto Urgent Care Services, LLC. hereinafter referred to as "Tenant," a  
16 parcel of land together with certain privileges, rights, uses and interests thereon, as set out  
17 in the Lease and Operating Agreement more fully described in Exhibit A attached hereto  
18 and made a part hereof; and

19 WHEREAS, Tenant proposes to lease from City the land described in  
20 Paragraph 1 of the Lease and Operating Agreement and to avail itself of certain privileges,  
21 rights and uses pertaining thereto; and


22 WHEREAS, Tenant, if granted a lease on the land, has indicated a  
23 willingness and ability to properly keep, maintain and improve the land in accordance with  
24 the Minimum Standards and Requirements for the Conduct of Aeronautical Services and  
25 Activities established and adopted by City.

8 to operate as a non-commercial aviation operator at the Slidell Airport.


