5 **ORDINANCE NO. 3379**

6 An ordinance amending Ordinance No. 3326, revising the Revenue, Expense
7 and Capital Budget for fiscal year 2006-2007 (second supplemental budget), providing for
8 supplemental appropriations, additional revenues and matters in connection therewith.
9

10 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
11 hereby amend Ordinance No. 3326, revising the Revenue, Expense and Capital Budget
12 for fiscal year 2006-2007, as attached herewith and made a part hereof.
13

15 BE IT FURTHER ORDAINED that the Slidell City Council does hereby
16 establish personnel staffing and position classification levels for each department as
17 presented in the Mayor's proposed budget booklet for fiscal year 2007, adopted May 23,
18 2006, and that the number of employees in each MSPG level shall be as therein stated for
19 each position, except that the Assistant Director of Parks & Recreation is changed from
20 Grade 11 exempt to Grade 13 exempt, one .5 full time equivalent Assistant Chief of Staff,
21 Grade 84, is added in Administration, the Director of Parks and Recreation is reduced by
22 one .5 full time equivalent, three part-time positions are eliminated in the Public Operations
23 Department, one full time Facility Manager (Grade 13) is added in the Public Operations
24 Department, one full time Crew Chief (Grade 8) is added in the Public Operations
25 Department effective March 2007.

29 BE IT FURTHER ORDAINED that Council approval is required to amend,
30 change, increase or reallocate any MSPG levels, or staffing except for Police Department


4 classifications for Police Officers, Corporals, and Sergeants, who shall have an automatic

17 signature by the Mayor.


