7 An ordinance annexing and zoning .87 acres of land from Parish C-2 Highway  
8 Commercial to City C-4 Highway Commercial, as petitioned by Clearbrook, L.L.C., Bruce  
9 Wagner, Sr. and Joseph Bacon.

10 WHEREAS, the Slidell City Council has received a petition from Clearbrook,  
11 L.L.C., Bruce Wagner, Sr. and Joseph Bacon to annex and zone .87 acres of land from  
12 Parish C-2 Highway Commercial to City C-4 Highway Commercial; and

15 WHEREAS, said property is located south of Brownswitch Road, and east of  
16 the bowling alley; and

18 WHEREAS, the Slidell Planning and Zoning Commission has issued a  
19 favorable recommendation for said annexation and zoning.

21 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that .87  
22 acres of land located south of Brownswitch Road, and east of the bowling alley, be  
23 annexed into the corporate limits of the City of Slidell into Councilmanic District G and  
24 zoned C-4 Highway Commercial, and more fully described as:


28 All that certain parcel of land, being more fully described as follows: From the  
29 section corner common to section 25, 06, 36 and 36 in said township and  
30 range, go south 1408.21 feet to the Southerly right-of-way line of Brownswitch  
31 Road; thence go along said right-of-way line North 89 degrees, 08 minutes,  
32 50 seconds East 1548.59 feet to the point of the beginning. Thence from the  
33 point of beginning continue along said right of way line North 89 degrees, 08  
34 minutes, 50 seconds East 200.00 feet to a point; thence go South 00 degrees,  
35 51 minutes, 47 seconds east 190 feet to a point; thence go south 89 degrees,  
36 08 minutes, 50 seconds west 200.00 feet to a point; thence go North 00  
37 degrees, 51 minutes, 47 seconds west 190.00 feet back to the point of the  
38 beginning.
