6 An ordinance annexing and zoning a portion of Lot 7, Scogin Partition (1177
7 & 1179 Fremaux Avenue), as petition by Warren Berault and John Schmidt, from Parish
8 Suburban Agriculture to City C-2 Neighborhood Commercial.

10 WHEREAS, the Slidell City Council has received a petition from Warren
11 Berault and John Schmidt to annex and zone a portion of Lot 7, Scogin Partition (1177 &
12 1179 Fremaux Avenue) from Parish Suburban Agriculture to City C-2 Neighborhood
13 Commercial; and

15 WHEREAS, said property is located at Fremaux Avenue and 11th Street; and

17 WHEREAS, the Slidell Planning and Zoning Commission has issued a
18 favorable recommendation for said annexation and zoning.


20 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that a
21 portion of Lot 7, Scogin Partition (1177 & 1179 Fremaux Avenue) is hereby annexed into
22 the corporate limits of the City of Slidell into Councilmanic District A and zoned C-2
23 Neighborhood Commercial, and more fully described as follows:


25 A portion of Lot No. 7 of Scogin Partition, together with all buildings and
26 improvements thereon in the Southwest quarter of Section 11, T-9-S, R-14-
27 E, St. Tammany Parish Louisiana, to-wit: From the Northwest corner of the
28 Southwest quarter of Section 11, T-9-S, R-14-E, go South 25.5 feet to the
29 place of beginning at a point on the south right of way line of U.S. Highway
30 No. 190; thence go South 165.0 feet; thence go East 85.0 feet; thence go
31 North 165.0 feet to a point on the south right of way line of U.S. Highway
32 #190; thence go West 85.0 feet along the south edge of the right of way of
33 U.S. Highway No. 190 to the place of beginning.
