8 "An ordinance amending the millage rates for the City of Slidell for fiscal
9 year 2009, number two (2).

11 NOW THEREFORE BE IT ORDAINED by the Slidell City Council of the
12 Parish of St. Tammany, Louisiana, in a public hearing held on December 2, 2008,
13 which hearing was conducted in accordance with the Open Meetings Law and the
14 additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and
15 R.S. 47:1705(B), that the taxing authority voted to increase the millage rate(s), but not
16 in excess of the prior year's maximum rate(s), on all taxable property shown on the
17 official assessment roll for the tax year 2008, and when collected, the revenues from
18 said taxes shall be used only for the specific purposes for which said taxes have been
19 levied. Said millage rate(s) are:

19 R.S.47:1705(B). The votes were:




