10 hereby amend Ordinance No. 3535, adopted May 26, 2009, as follows:

12 Page 2, line 25, delete the paragraph beginning "A tax of 3.67 mills . . ." in its
13 entirety and replace with:

15 "A tax of 3.67 mills for the purpose of providing an amount sufficient to
16 pay interest and maturing bonds for the 2005 General Obligation Refunding Bonds of the
17 City of Slidell, Louisiana, for the year 2009, as authorized by a special election held
18 November 18, 1995, and by a Resolution of the Mayor and the Council Members of the
19 City of Slidell, Louisiana, passed on the 14th day of December, 2004."
