7 An ordinance amending the millage rates for the City of Slidell for fiscal year
8 2012, number two (2).

9 NOW THEREFORE BE IT ORDAINED by the Slidell City Council of the
10 Parish of St. Tammany, Louisiana, in a public hearing held on August 23, 2011, which
11 hearing was conducted in accordance with the Open Meetings Law and the additional
12 requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S.
13 47:1705(B), that the taxing authority voted to increase the millage rate(s), but not in excess
14 of the prior year's maximum rate(s), on all taxable property shown on the official
15 assessment roll for the tax year 2011, and when collected, the revenues from said taxes
16 shall be used only for the specific purposes for which said taxes have been levied. Said
17 millage rate(s) are:




