8 An Ordinance amending Ordinance No. 3461 adopted on March 25, 2008,  
9 levying an additional sales tax of one percent (1.00%) in the Fremaux Economic  
10 Development District, State of Louisiana (The "District"), and providing for other matters in  
11 connection therewith in order to reduce the sales tax levy from one percent (1.00%) to  
12 one-half of one percent (0.50%) and providing for other matters in connection with the  
foregoing.

13 WHEREAS, Part II, Chapter 27, Title 33 of the Louisiana Revised Statutes of  
14 1950, as amended (La. R.S. 33:9038.31, et seq.) (the "Act") authorizes municipalities,  
15 parishes and certain other local governmental subdivisions to create economic  
16 development districts to carry out the purposes of the Act, which economic development  
17 districts are political subdivisions of the State of Louisiana and possess such power and  
18 authority and have such duties as provided by the Act and other law; and

23 WHEREAS, by Ordinance No. 3460, the governing authority of the City of  
24 Slidell, State of Louisiana (the "City") created the Fremaux Economic Development  
25 District, State of Louisiana (the "District"), in accordance with La. R.S. 33:9038.32; and

28 WHEREAS, La. R.S. 33:9038.39 permits the District to levy an additional  
29 sales and use tax for authorized purposes; and

32 WHEREAS, Pursuant to La. R.S. 33:9038.39 and Ordinance No. 3461 the  
33 District levied an additional sales and use tax in the amount of one percent (1.00%) within  
34 the District and provided for other matters with respect thereto; and

4 WHEREAS, the District desires to reduce the additional sales tax levied  
5  
6 pursuant to Ordinance No. 3461 from one percent (1.00%) to one-half of one percent  
7 (0.50%), effective on the date of the adoption of this ordinance.  
8

9 NOW THEREFORE, BE IT HEREBY ORDAINED by the Slidell City Council,  
10 acting as the governing authority of the District; that:

11 SECTION 1. All of the above "Whereas" clauses are adopted as part of this  
12 ordinance.  
13

14 SECTION 2. Amendment to Ordinance No. 3461. Ordinance No. 3461 is hereby  
15 amended to reduce the levy of the sales tax levied therein from one percent (1.00%) to  
16 one-half of one percent (0.50%) effective the date of adoption of this ordinance. All  
17 references to the amount of sales tax levied in Ordinance No. 3461 are hereby amended  
18 from (1.00%) to one-half of one percent (0.50%) effective the date of adoption of this  
19 ordinance. Except as modified hereby, Ordinance No. 3461 shall remain in full force and  
20 effect.

21 SECTION 3. Authorization of Officers. The President of the Council and his staff  
22 are hereby authorized, empowered and directed to do any and all things necessary and  
23 incidental to carry out the provisions of this ordinance.

24 SECTION 4. Severability. If any provision of this ordinance shall be held to be  
25 illegal or invalid, such illegality or invalidity shall not affect any other provision of this  
26 ordinance, but this ordinance shall be construed and enforced as if such illegal or invalid  
27 provisions had not been contained herein. Any constitutional or statutory provision  
28 enacted after the date of this ordinance which validates or makes legal any provision of  
29 this ordinance which would not otherwise be valid or legal, shall be deemed to apply to this  
30 ordinance.

31 SECTION 5. Repealer. All ordinances or resolution, or parts thereof, in conflict  
32 herewith are hereby repealed.


33 SECTION 6. Publication; Effective Date. This ordinance shall be published one


