6 **ORDINANCE NO. 3660**

7 An ordinance amending Ordinance No. 3612, revising the Revenue, Expense
8 and Capital Budget for fiscal year 2011-2012 (Second Supplemental Budget), providing for
9 supplemental appropriations, additional revenues and matters in connection therewith.

10 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
11 hereby amend Ordinance No. 3612, revising the Revenue, Expense and Capital Budget
12 for fiscal year 2011-2012, as attached herewith and made a part hereof.

14 BE IT FURTHER ORDAINED that Council approval is required to amend,
15 change, increase or reallocate any MSPG levels, or staffing except for Police Department
16 classifications for Police Officers, Corporals, and Sergeants, who shall have an automatic
17 promotion depending upon time in service and job performance.
18

19 BE IT FURTHER ORDAINED that each item listed in the attached Capital
20 Outlay Schedules shall constitute a separate program, and substitutions thereto shall
21 require Council approval.

23 BE IT FURTHER ORDAINED by the Slidell City Council that it does hereby
24 revise the schedule of operating adjustments by adding \$1,000.00 in the City Prosecutor
25 line item for part-time salaries and medical.


27 BE IT FURTHER ORDAINED that the Finance Director is authorized to make


4 BE IT FINALLY ORDAINED that the Finance Director is authorized to make
