7 An ordinance amending the Code of Ordinances of the City of Slidell,  
8 Chapter 27, Traffic and Vehicles, Article I, In General, Section 27.1(b), State Laws  
9 Adopted, by replacing the general civil penalty provision (Section 1-12) presently set out  
10 therein with the penalty provisions set out in Chapter 11, Criminal Code, Article I, General  
11 Provisions, Section 11.4.

12 WHEREAS, the City is desirous of amending Slidell City Code of Ordinances,  
13 Chapter 27, Traffic and Vehicles, Article I, In General, Section 27.1(b), State Laws  
14 Adopted, *which presently reads:*

15

17 “(b) Each act or failure to act made an offense when committed upon a state  
18 highway, or with respect to the operation of a vehicle upon a highway of the state in  
19 such regulatory act and the administrative provisions of such regulatory act is made  
20 an offense when committed upon or with respect to any street in the city. Any  
21 person violating such provisions shall be punished as provided in section 1-12 of  
22 this Code.”

27 WHEREAS, the City is desirous of amending Slidell City Code of Ordinance,  
28 Chapter 27, Traffic and Vehicles, Article I, In General, Section 27.1(b), State Laws  
29 Adopted, *to read as follows:*

32 **“(b) Any person violating such provisions as provided in paragraph (a) shall**  
33 **be punished as provided in Section 11.4 of this Code.”**


4 **NOW THEREFORE BE IT ORDAINED** by the Slidell City Council that it does

9 **Section 27.1(b), State Laws Adopted.**


10 Delete paragraph "(b)" in its entirety and replace with the following:
