7 **ORDINANCE NO. 3668**

8 An ordinance annexing and zoning property located at 800 Brownsitch  
9 Road, more particularly identified as a parcel of land containing 1.966 acres in Section 36,  
10 Township 8 South, Range 14 East, from Parish HC-1 Highway Commercial to City C-2  
11 Neighborhood Commercial, as petitioned by St. Tammany Fire Protection District 1,  
12 through Linfield, Hunter & Junius, Inc.

13 WHEREAS, the Slidell City Council has received a petition from St. Tammany  
14 Fire Protection District 1 through Linfield, Hunter & Junius, Inc., to annex and zone  
15 property located at 800 Brownsitch Road, more particularly identified as a parcel of land  
16 containing 1.966 acres in Section 36, Township 8 South, Range 14 East, from Parish HC-1  
17 Highway Commercial to City C-2 Neighborhood Commercial; and

21 WHEREAS, said property is located 800 Brownsitch Road; and

23 WHEREAS, the Slidell Planning and Zoning Commission has issued a  
24 favorable recommendation for said annexation and zoning with the condition that in  
25 coordination with the St. Tammany Parish Council, the overall dimensions of the new CVS  
26 Pharmacy must not be more than 14,000 square feet.


29 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the

32 the corporate limits of the City of Slidell into Councilmanic District G and zoned C-2  
33 Neighborhood Commercial, with the condition that the overall dimensions of the new CVS
