7 **ORDINANCE NO. 3671**

8 An ordinance amending the Code of Ordinances of the City of Slidell, Chapter
9 21 Personnel, relative to retirement contributions.

11 WHEREAS, all City employees, the Mayor, Chief of Police, City Council
12 Members and City Court Judge participate in either a retirement system plan or deferred
13 compensation plan; and

16 WHEREAS, the City has paid the employee portion of retirement plan
17 contributions or its deferred comp plan equivalents for employees hired prior to 4/26/2011;

21 WHEREAS, the City's fiscal circumstance is such that such contributions and
22 equivalents are no longer affordable;

24 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
25 Code of Ordinances of the City of Slidell, Chapter 21 Personnel is hereby amended as
26 follows:

29 Ordinance Section 21-81(e) is hereby amended to add the following
30 language: "Notwithstanding any provision to the contrary, any person subject to this
31 subsection shall pay fifty percent (50%) of the contributions referenced herein from their
32 own funds beginning July 1, 2013 and shall pay one hundred percent (100%) of such
33 contributions from their own funds beginning July 1, 2014."

8 contributions from their own funds beginning July 1, 2014."

16 contributions from their own funds beginning July 1, 2014."

22 pay fifty percent (50%) of the contributions referenced herein from their own funds

24 from their own funds beginning July 1, 2014."

32 contributions from their own funds beginning July 1, 2014."
