11 property on the list dated 5/7/2013 1:31 p.m., attached hereto and made a part hereof, is no  
12 longer needed by the City of Slidell for public use and is hereby declared surplus and shall  
13 be sold to the highest bidder who shall submit a sealed bid meeting specifications, or at a  
14 duly advertised public auction.

18 BE IT FURTHER ORDAINED that the date, time, and place of sale are to be  
19 fixed by the Mayor of Slidell, who shall also establish method of payment and other  
20 specifications for bidders, including deadline for removal.

23 BE IT FURTHER ORDAINED that surplus Police Department vehicles may be  
24 subject to sale by auction to other law enforcement agencies or political subdivisions at a  
25 time, date and place determined by the Mayor or his designee who shall also establish  
26 method of payment and other requirements for bidders including deadline for removal.
