ORDINANCE NO. 3702

An ordinance authorizing the Mayor to execute an Act of Dedication and Donation ("Act") accepting the donation and dedication of Infrastructure Improvements and Public Land from the Slidell Development Company, LLC ("SDC"), pursuant to the Development Agreement/Cooperative Endeavor Agreement entered into by and between the City of Slidell ("City") and Slidell Development Company, LLC, on March 25, 2008.

WHEREAS, the City Council adopted Resolution R08-22 on the 25th day of March, 2008, authorizing the Mayor to execute a Development Agreement relative to the Summit Fremaux Project (now known as the Fremaux Town Center); and

WHEREAS, the City and SDC entered into a Development Agreement/
Cooperative Endeavor Agreement ("Agreement") on the 13th day of May 2008; and

WHEREAS, Article III of the Agreement, entitled: Dedication and Acceptance of Infrastructure Improvements and Public Land, Paragraph 3.1, sets out, in part, "...SDC shall dedicate, or cause to be dedicated, pursuant to a subdivision plat, the Public Land (including all applicable servitudes) to the City, as applicable, and such Parties shall accept the dedicated Public Land. Upon completion of the Infrastructure Improvements, the City shall accept the dedication of the Infrastructure Improvements within thirty (30) days following the completion in accordance with the approved Infrastructure Improvements Plans; and

WHEREAS, SDC is the owner of a parcel of land designated as "PARCEL, W-14A," containing 11.202 acres or 487,955 square feet, located in Section 14, Township 9 South, Range 14 East, Greensburg Land District, St. Tammany Parish, Louisiana; and

WHEREAS, Infrastructure Improvements, as defined in the Agreement and set out in Exhibit B attached thereto, includes W-14 Canal Improvements to be engineered, constructed and paid for by SDC; and

WHEREAS, SDC has completed the Infrastructure Improvements; and

WHEREAS, the Act does transfer, for public use, all of SDC/Donor's rights, titles and interests in and to the land owned by SDC/Donor within the property described on Exhibit A of the Act of Dedication and Donation and made a part thereof to the City/Donee; and

WHEREAS, the City and SDC agree that the City may assign its rights and obligations under this Act to St. Tammany Parish, subject to the terms of this Act; and further that the City's acceptance of that part of the Act pertaining to the W-14 shall not and does not serve as a waiver of rights of any kind or nature between the City and St. Tammany Parish; and

WHEREAS, requirements of the Agreement include, but are not limited to:
Article V. Representations and Warranties

Section 5.2 Representations Of The Government Parties, reads in part:

(a) The City has the legal power and authority to enter into this Agreement, to make the respective commitments made in this Agreement and to perform its respective

obligations under this Agreement, and to the extent that any authorization, approval or consent of any government authority, body or agency or third party is required for it to have entered into this Agreement and make the commitments contained in this Agreement, such authorizations, approvals and consents have been duly obtained in accordance with applicable law and procedures. In furtherance of the foregoing, the City has adopted or entered into all original and duly authorized resolutions and/or agreements or ordinances if any, necessary so that this Agreement may be properly authorized and executed. This Agreement constitutes the valid and binding obligation of the City, enforceable in accordance with its terms. True and correct copies of all documents referenced in this Section 5.2(a) have been provided to SDC;

- (b) The City is not prohibited from consummating the transactions contemplated in this Agreement by any law, regulation, agreement, instrument, restriction, order or judgment;
- (c) The City has determined that there are sufficient public purposes served by this Agreement for each to enter into this Agreement and to perform its obligations hereunder; and

WHEREAS, the Mayor, pursuant to Resolution R08-22 and the terms of the Agreement, signed the Act of Dedication and Donation on July 15, 2013; and

WHEREAS, the City Council, consistent with and pursuant to Resolution R 08-22 and the terms of the Agreement, hereby ratifies the Mayor's signing of the Act of Dedication and Donation on July 15, 2013; and

WHEREAS, the City believes that the Fremaux Town Center (formerly Summit Fremaux) will be economically beneficial to the City and the entire area; and

WHEREAS, the parties to the Agreement acknowledge that they will mutually and commensurately benefit.

NOW THEREFORE BE IT ORDAINED that the Slidell City Council does hereby ratify the Mayor's signing of the Act of Dedication and Donation on July 15, 2013.
