7 An ordinance accepting ownership of Southwest Frontage Road at the
8 Fremaux Town Center.

10 WHEREAS, The City of Slidell desires to accept ownership of whatever
11 rights the State of Louisiana, through the Department of Transportation and Development
12 (“Department”), may own, with the exception of any and all mineral rights, in and to the
13 following described property and agrees to accept all duties, obligations, and
14 responsibilities for the operation, maintenance, and liabilities associated therewith, for its
15 use as a city street:

16
17 The frontage road in its entirety located in the southwest quadrant of the Interstate
18 route I-10 and state route US 190 Business (Fremaux Avenue) interchange from its
19 intersection with state route US 190 Business located approximately 0.24 mile
20 northwest of the intersection of Interstate route I-10 and state route US 190
21 Business then proceeding southeast approximately 0.20 mile to its terminus and
22 continuation as a local road.

24 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the
25 City of Slidell shall accept ownership of whatever rights the Department may own in and to
26 the aforesaid described property as a binding agreement between the State of Louisiana
27 and the City of Slidell.

29 BE IT FURTHER ORDAINED that the Slidell City Council authorizes the
30 Mayor of the City of Slidell to execute the documents necessary to transfer the aforesaid
31 described property.
