8 An ordinance authorizing the Mayor to enter into and execute a lease for the  
9 property located at 1514 W. Lindberg Street, Slidell, Louisiana, with Janice Smith Stumpf  
10 and the Johnny F. Smith Testamentary Trust, to be used by the Louisiana Department of  
11 Motor Vehicles.

12 WHEREAS, the State of Louisiana notified the City of Slidell of its intentions  
13  
14 to close the Slidell Office of the Louisiana Department of Motor Vehicles ("DMV Office");  
15  
16 and

17 WHEREAS, the City of Slidell is making every effort to ensure that the DMV  
18  
19 Office remains open for the benefit of its citizens; and

20 WHEREAS, the State of Louisiana presently maintains a month to month  
21  
22 lease for the property located at 1514 W. Lindberg Street, Slidell, Louisiana; for the  
23  
24 operation of the Slidell DMV Office; and

25 WHEREAS, the City of Slidell believes it is in the best interest of its citizens  
26  
27 to maintain a Slidell DMV Office and to do so at the present location, where the Louisiana  
28  
29 Department of Motor Vehicles presently offers DMV services; and

30 WHEREAS, Janice Smith Stumpf and the Johnny F. Smith Testamentary  
31  
32 Trust are the present Landlords for the property leased by the State, located at 1514  
33  
34 Lindberg Street, Louisiana; and

35 WHEREAS, the City of Slidell desires to enter into a new three (3) year lease  
36  
37 agreement with the same landlord at the same location identified above; and

4 WHEREAS, the proposed lease sets out that in the event that public funding  
5 for the City of Slidell becomes inadequate to meet the obligations of this lease, the City of  
6 Slidell may terminate the lease or reduce its space provided by giving a sixty (60) day  
7 notice to Lessor; and

10 WHEREAS, the City of Slidell desires the City Council to authorize the Mayor  
11 to enter a lease for the property located at 1514 Lindberg Street, Louisiana.

13 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that the  
14 Mayor is hereby authorized to enter into and execute a lease with Janice Smith Stumpf  
15 and the Johnny F. Smith Testamentary Trust, Landlords for the property located at 1514  
16 Lindberg Street, Louisiana to be used by the Louisiana Department of Motor Vehicles;  
17 copy of which is attached hereto and made a part hereof.

21 adoption.
