ORDINANCE NO. 3775

An ordinance establishing a new Classified Pay Plan for the City of Slidell.

WHEREAS, the City of Slidell directed the Civil Service Director to develop a new pay plan for its classified employees; and

WHEREAS, the Civil Service Director has made certain recommendations;

WHEREAS, the City Administration, City Council, Compensation Task Force, and the Civil Service Board have worked together to develop a new pay plan for the classified employees of the City of Slidell; and

WHEREAS, an Open Range Salary Matrix has been formulated consisting of fifteen (15) grades with a Minimum, Mid-Point and Maximum, and an average 60% percent range difference between minimum and maximum; and

WHEREAS, classified positions have been identified by grade and proposed in the FY2016 budget; and

WHEREAS, the City Administration, Compensation Task Force and Civil Service Board have recommended a five (5) percent salary structure adjustment to the open range salary matrix for FY 2016, and

WHEREAS, employees who are on probation will be brought to the new minimum of the salary grade, and will receive the remainder of the 50 cent per hour salary adjustment, if any, upon completion of probation

WHEREAS, a 50 cent per hour salary adjustment for all classified employees who are not on probation and who have received a satisfactory performance evaluation will be granted for FY 2016.

WHEREAS, the Civil Service Board granted an exception to Rule 21.06, Rates of Pay in the Pay Plan, for FY 2016, subparagraph (1), waiving the maximum of the grade.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does hereby adopt the Pay Plan, Open Range Salary Matrix, grade structure, job class hierarchy for the classified employees of the City of Slidell as adopted by the City of Slidell Civil Service Board, all as attached hereto and made a part hereof.

BE IT FURTHER ORDAINED by the Slidell City Council that it does hereby adopt the Civil Service Board exception to Rule 21.06, Rates of Pay in the Pay Plan, for FY2016, subparagraph (1), waiving the maximum of the grade.

BE IT FURTHER ORDAINED that any classified Pay Plan in contradiction herewith is hereby rescinded.

BE IT FINALLY ORDAINED that this Ordinance is effective July 1, 2015.
