7 An ordinance amending Ordinance No. 3771, revising the Revenue, Expense  
8 and Capital Budget for fiscal year 2015-2016 (first supplemental budget), providing for  
9 supplemental appropriations, additional revenues and matters in connection therewith.

10  
11 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does  
12 hereby amend Ordinance No. 3771, revising the Revenue, Expense and Capital Budget  
13 for fiscal year 2015-2016, as attached herewith and made a part hereof.

14  
15 BE IT FURTHER ORDAINED that Council approval is required to amend,  
16 change, increase or reallocate any MSPG levels, or staffing except certain positions in the  
17 Police Department, Wastewater Treatment Plant Division and in the Building Safety  
18 Department, who shall have automatic promotions depending upon time in service and job  
19 performance in accordance with Civil Service rules and with the approval of the Civil  
20 Service Director.

23 BE IT FURTHER ORDAINED that one part-time legal assistant be added to  
24 the City Attorney's office; and

25  
26 BE IT FURTHER ORDAINED that \$35,000 be added to General Funds, City  
27 Marshall and \$35,000 be subtracted from Sales Tax Funds, Reserve-Undesignated.

29 BE IT FURTHER ORDAINED that each item listed in the attached Capital  
30 Outlay Schedules shall constitute a separate program, and substitutions thereto shall  
31 require Council approval; and
