8 An ordinance annexing a certain portion of a water bottom known as Bayou  
9 Bonfouca as petitioned by the Office of State Lands, State of Louisiana.

10 WHEREAS, the Office of State Lands, State of Louisiana, represented by  
11 Jonathan Robillard, Public Lands Administrator, petitioned the City of Slidell, Louisiana, for  
12 the annexation of property into the corporate limits of the City of Slidell (Copy of Petition  
13 for Annexation is attached hereto and made a part hereof); and

16 WHEREAS, the property to be annexed is described as follows:

18 A certain portion of a water bottom known as Bayou Bonfouca, being that  
19 portion of said water bottom lying between La. Hwy. 433, also known as  
20 Bayou Liberty Rd., and West Hall; and

22 WHEREAS, the subject property is further described as lying contiguous and  
23 adjacent to the City of Slidell and is located in the Parish of St. Tammany, in Township 9  
24 South, Range 14 East. This property does not include any portion of a public road or  
25 highway; and

28 WHEREAS, this petition and request for annexation is made for and on  
29 behalf of the City of Slidell, pursuant to its request that the state petition for the annexation  
30 of the above described property; and

33 NOW THEREFORE BE IT ORDAINED, by the Slidell City Council, in legal  
34 session convened, that the following described property be and is hereby incorporated into


