6 **ORDINANCE NO. 3858**

8 An ordinance for the City of Slidell which shall set forth and designate the
9 adjusted millage rates as required by Paragraph B of Section 23, Article VII of the
10 Constitution of Louisiana, for the purpose of maintenance and operation of the Police
11 Department, Garbage Collection, Sewer System, Public Works, General Government, as
12 well as providing for the payment of interest and principal on outstanding general
obligation bonds, in said City for the fiscal year 2018.

13 SECTION 1. BE IT ORDAINED by the Slidell City Council of the City of
14 Slidell, Louisiana, in legal session convened, that there is hereby levied an aggregate tax
15 of 27.08 mills on the dollar upon all property taxable, under the laws of the State of
16 Louisiana, situated in said City, according to the assessment roll of said City in the
17 calendar year 2017.

21 SECTION 2. BE IT FURTHER ORDAINED that said aggregate tax is
22 composed of the following individual authorized tax levys:
23

24 A tax of 5.08 mills for the purpose of raising and providing sufficient revenues
25 to pay and defray the expenses of the municipal government and for the general municipal
26 and local purposes in the City of Slidell, Louisiana, for the year 2017, as shown by the
27 budget for the year 2018, adopted by the City Council of said City. So authorized by
28 Louisiana Constitution Article VI, Section 27.

31 A tax of 3.00 mills for the purpose of maintenance and operation of the
32 Municipal Police Department in the City of Slidell, Louisiana, for the year 2018. So
33 authorized by the special taxpayer election held in the City of Slidell, Louisiana, November
34 19, 2013.

4 A tax of 2.13 mills for the purpose of maintenance and operation of the

10 A tax of 4.00 mills for the purpose of garbage disposal and maintenance in

15 A tax of 5.00 mills for the purpose of maintenance of the sewerage system of
16 the City of Slidell, Louisiana, for the year 2018. So authorized by the special taxpayer
17 election held in the City of Slidell, Louisiana, November 19, 2013.

20 A tax of 2.03 mills for the purpose of maintaining, operating, and improving
21 public works within the City of Slidell, Louisiana, for the year 2018. So authorized by the
22 special taxpayer election held in the City of Slidell, Louisiana, April 4, 1981.

25 A tax of 2.27 mills for the purpose of providing an amount sufficient to pay
26 interest and maturing bonds for the 2010 General Obligation Bonds for the City of Slidell,
27 Louisiana, for the year 2017, as authorized by a special election held October 17, 2009,
28 and by a Resolution of the Mayor and Council Members of the City of Slidell, Louisiana,
29 passed on the 28th day of July, 2009.

33 A tax of 2.88 mills for the purpose of providing an amount sufficient to pay
34 interest and maturing bonds for the 2016 General Obligation Bonds for the City of Slidell,
35 Louisiana, for the year 2017, as authorized by a special election held April 9, 2016 and by


