7 An ordinance authorizing the Mayor to execute a Contract for Emergency and  
8 Non-Emergency Services.  
9

10 WHEREAS, the health and safety of the citizens of Slidell and of those who  
11 are visitors to the City are vitally important; and  
12

13 WHEREAS, the Slidell City Council finds that the provision of emergency and  
14 non-emergency ambulance service through a sole provider will provide a greater level of  
15 ambulance service to those who require it; and  
16  
17

18 WHEREAS, the Slidell City Council authorized the Mayor to Execute a  
19 Contract with Acadian Ambulance Service, Inc. that expires on May 31, 2019; and  
20

22 WHEREAS, the Slidell City Council recognizes the need to ensure consistent  
23 and necessary emergency and non-emergency ambulance services and therefore, has  
24 determined that it is in the best interest of the citizens of Slidell and its guests to negotiate  
25 a new contract with Acadian Ambulance Service, Inc.; and

28 WHEREAS, the Slidell City Council, considering weather related disasters  
29 and the other possible and unpredicted emergency circumstances that have or may affect  
30 the citizens of the City of Slidell, desires to terminate its present contract and enter into a  
31 new contract with Acadian Ambulance Service, Inc.; and


