## **ORDINANCE NO. 3886**

An ordinance repealing Ordinance No. 3860 adopted on April 25, 2017, entitled "An ordinance providing for the issuance and sale of not to exceed Eleven Million One Hundred Fifty Thousand Dollars (\$11,150,000) of Utilities Revenue Bonds of the City of Slidell, State of Louisiana; prescribing the form, terms and conditions of such bonds and providing for the payment thereof; providing for the sale of such bonds; authorizing an agreement with a paying agent in connection with such bonds; and providing for other matters in connection therewith".

WHEREAS, this Slidell City Council (the "Governing Authority"), acting as the governing authority of the City of Slidell, State of Louisiana (the "City") adopted Ordinance No. 3860 on April 25, 2017 (the "Prior Ordinance"), providing for the issuance and sale of \$11,150,000 of Utilities Revenue Bonds for the purpose of (i) constructing, acquiring, extending and/or improving the Utilities System of the Issuer (the "Project"), (ii) funding a reserve (if required), and (iii) paying the costs of issuance of the Bonds; and

WHEREAS, this Governing Authority has determined not to issue the bonds approved by the Prior Ordinance; and

WHEREAS, this Governing Authority now wishes to repeal the Prior Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council, acting as the governing authority of the City, that:

**SECTION 1.** The Prior Ordinance is hereby repealed in its entirety.

**SECTION 2.** This Ordinance shall become effective immediately.
