8 An ordinance amending Ordinance No. 3049 to change the name on the non-
9 commercial aviation operator lease agreement with Peter Hertzak, at the Slidell Airport.

11 WHEREAS, the Airport Manager has requested that the named lessee on the
12 Lease and Operating Agreement attached to Ordinance No. 3049 as Exhibit A, be
13 changed from Peter Hertzak to Air Reldan, Inc.; and

16 WHEREAS, the Lease entered into by and between the City of Slidell and
17 Peter Hertzak has been assigned, with the authorization of the City, to Air Reldan, Inc.;

21 WHEREAS, the City Council adopted Ordinance No. 3894 permitting the
22 lease of Airport Hangars for Commercial and/or Non-Commercial purposes; and

24 WHEREAS, Air Reldan, Inc. is in the process of affecting the purchase of
25 Hangar owned by Peter Hertzak, through his court appointed Curator, G. Brice Jones, by
26 Power of Attorney; and

29 WHEREAS, City is amending the current lease to change the name on the
30 lease and to include Commercial Operations, as well as, Non-Commercial operations; and

32 WHEREAS, the amended lease shall contain terms and conditions related to
33 Commercial operations; and




4 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
