WHEREAS, City desires to amend Chapter 27 of the City of Slidell Code of Ordinances by adding certain sections of Louisiana Revised Statute Title 47 to include:

- R.S. 47:478 Trucks to bear name and address of owner or lessee; exceptions.
- R.S. 47:501 Owner to secure registration
- R.S. 47:506 Registration certificates
- R.S. 47:508 Registration; commercial vehicles; exemption
- R.S. 47:513 Vehicle of nonresident owner used regularly in business in

R.S. 47:536 Violations of registration provisions; and

WHEREAS, City believes it is in the best interest of the City and its Citizens to Amend Chapter 27 as set out below; and

WHEREAS, City plainly and clearly declares and mandates that all previous City Ordinances repealed and/or amended by this Ordinance still exist for crimes that were committed and/or charged, prior to the adoption and enactment hereof.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does hereby amend the Code of Ordinances of the City of Slidell, Chapter 27, as follows:

Add: Article IX, Vehicle Registration and Certificates

Add: Sec. 27-204 Vehicle of nonresident owner used regularly in business in Louisiana

Add: Sec. 27- 205 Violations of registration provisions.
