7 **ORDINANCE NO. 3922**

8 An ordinance amending the Code of Ordinances of the City of Slidell,
9 Chapter 27, Traffic and Vehicles, relative to state laws adopted.

11 WHEREAS, Louisiana Constitution, City of Slidell Home Rule Charter, and
12 certain Louisiana Revised Statutes authorizes the City of Slidell to adopt Louisiana state
13 law as City Ordinances; and

16 WHEREAS, City asserts that it is in the best interest of the City and its
17 citizens to adopt certain State laws as City Ordinances; and

20 WHEREAS, City desires to adopt certain sections of Louisiana Revised
21 Statute Title 47 as they currently exist, and adopt all future amendments, supplements,
22 modifications, revisions, deletions and changes thereto, except for such provisions and
23 regulations as by their nature can have no application in the City, and except as otherwise
24 provided in this Code or by ordinance, and within existing City Ordinance Chapter 27; and

27 WHEREAS, City desires to amend Chapter 27 of the City of Slidell Code of
28 Ordinances by adding certain sections of Louisiana Revised Statute Title 47 to include:

30 R.S. 47:478 Trucks to bear name and address of owner or lessee; exceptions.

31 R.S. 47:501 Owner to secure registration

32 R.S. 47:506 Registration certificates

33 R.S. 47:508 Registration; commercial vehicles; exemption

34 R.S. 47:513 Vehicle of nonresident owner used regularly in business in

8 WHEREAS, City believes it is in the best interest of the City and its Citizens to
9
10 Amend Chapter 27 as set out below; and

11 WHEREAS, City plainly and clearly declares and mandates that all previous
12
13 City Ordinances repealed and/or amended by this Ordinance still exist for crimes that were
14
15 committed and/or charged, prior to the adoption and enactment hereof.

17 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that it does
18
19 hereby amend the Code of Ordinances of the City of Slidell, Chapter 27, as follows:

21 Add: **Article IX, Vehicle Registration and Certificates**

22
23 Add: Sec. 27-200 Trucks to bear name and address of owner or lessee;
24 exceptions.

25 Add: Sec. 27-201 Owner to secure registration

26 Add: Sec. 27-202 Registration certificates

27 Add: Sec. 27-203 Registration; commercial vehicles; exemption

28 Add: Sec. 27-204 Vehicle of nonresident owner used regularly in business in
29 Louisiana

30 Add: Sec. 27- 205 Violations of registration provisions.

19 except as otherwise provided in this Code or by ordinance, and within existing City

21 Ordinance Chapter 27.
