### **ORDINANCE NO. 3928**

An ordinance amending the Code of Ordinances of the City of Slidell, Chapter 11, Criminal Code, relative to state laws as adopted by Ordinance No. 3921 on the 18<sup>th</sup> day of December 2018.

WHEREAS, City plainly and clearly declares and mandates that all previous City Ordinances repealed and/or amended by this Ordinance still exist for crimes that were committed and/or charged, prior to the adoption and enactment hereof; and

WHEREAS, by Ordinance 3921, City the Method of Citation in Chapter 11 of the City of Slidell Code of Ordinances such that whenever reference is made in Chapter 11 to a Louisiana Revised Statute Titles 14 and/or 40 that has been adopted as a Slidell City Ordinance pursuant to 11-1; and

WHEREAS, Ordinance 3921, adopted the 18th day of December 2018 is hereby amended to properly number Section 11-183 of Article VII, and repeal Article V, Section11-118, and Article VI, Section 11-195.
