7 An ordinance accepting a donation of property from the Boys & Girls Clubs of  
8 Southeast Louisiana, Inc. of a certain parcel of property with a community pool and  
9 authorizing the Mayor to execute an acceptance to the Act of Donation.

11 WHEREAS, Louisiana Constitution Art. 6, § 23, Acquisition of Property,  
12 states, "Section 23. Subject to and not inconsistent with this constitution and subject to  
13 restrictions provided by general law, political subdivisions may acquire property for any  
14 public purpose by purchase, donation, expropriation, exchange, or otherwise"; and

18 WHEREAS, City of Slidell Home Rule Charter, Part I, Article I, Sections 1-05  
19 and 1-06, and Article II, Section 2-10(A)(12) provides authorization, via ordinance, for the  
20 acquisition/purchase of property for a public purpose; and

24 WHEREAS, Boys & Girls Clubs of Southeast Louisiana, Inc. ("Donor")  
25 desires to donate a certain piece of property in Slidell, Louisiana, containing 0.86 acre,  
26 more or less ("Property"); and

29 WHEREAS, City of Slidell ("City") desires to acquire the Property for public  
30 purposes, and accept the donation of same.



